REPORT

1. Status of ratification of AMCOMET Constitution

Nine (9) countries in Africa have ratified the AMCOMET Constitution. These are Burkina Faso, Chad, Egypt, The Gambia, Liberia, Libya, Mali, Morocco, and Mozambique. Some countries including Senegal, South Africa and Tanzania are in the process of ratification.

The ratification issue was discussed at the Bureau meeting held on 9 September 2022 in Maputo, Mozambique, at the margins of the Southern Africa Ministerial Conference on Early Warning Early Action (5-8 September 2022) in which the Bureau was invited. According to the Vienna treaty, ratifying the AMCOMET Constitution may not be compulsory since during the AMCOMET-3 session held in Praia, Cabo Verde, the Assembly of the Ministers approved the constitution and modus operandi as contained in the Praia Declaration. On this basis, some countries do not go through the ratification process but pay their contribution. However, the bureau requested further advice from legal offices who confirmed the treaty and specificities of the countries that may have national internal procedures.

2. Status of Contributions as of 2023

Contributions, as shown in Table 1, vary from year to year and are often sent during the second part of the year, or sometimes the following year. The contributions are listed in the table below.

The total contribution to date is CHF 254,719.

3. Activities

3.1 Joint Working Group on the Abidjan Declaration

For a successful implementation of the Abidjan Declaration, a joint working group is composed of AUC, RECs, supported by Regional Climate Centres (RCCs), the President of Regional Association I, and the AMCOMET Expert Chair. WMO and EUMETSAT are invited as Observers, while the AMCOMET secretariat and EUMETSAT serve as co-secretariat of the joint working group. Few meetings towards the operationalization of the Abidjan Declaration have been organized.

A project concept, considering RECs priorities, has been developed to seek funds for the establishment of the African Meteorological Satellite Applications Facility (AMSAF) and to ensure Africa's preparedness and smooth transition to Meteosat Third Generation (MTG) as well as sustainability in accessing and using satellite data.

As part of the joint working group resource mobilization efforts, AMCOMET presented the concept at the following events:

- The high-level forum on 'Europe-Africa Space Earth Observation', June 2021;
- A meeting organized by the African Union Commission with the European Union delegation in Ethiopia in July 2021;
- The fourteenth EUMETSAT online User Forum, with the participation of the AMCOMET Chair at the opening ceremony, October 2021;
- The fifteenth EUMETSAT User Forum and High-level event MTG/AMSAF with the participation of the AMCOMET Chair;
- The MTG-AMSAF Workshop with the Directorate-General for International Partnerships organized by EUMETSAT on 30-31 March 2023 in Brussels, Belgium.

The concept note has been redrafted to re-focus on EW4ALL which has become the priority of all donors in line with the Dar es Salaam high-level statement. The African Union Commission has awarded a contract within a ClimSA grant to upgrade all the preparation for the use of Meteosat second generation in Africa (PUMA) reception stations and make them compatible with the new MTG satellite. An initial implementation of the AMSAF, focusing on nowcasting to support early warning, is planned under the new Europe-Africa space cooperation programme. It will build on ongoing projects such as the Weather and Climate Information Services Early Warning for Southern Africa (WISER-EWSA) Project and the Severe Weather Forecasting programme.

3.2 Release of the State of the Climate in Africa Reports

The AMCOMET Chair participated in the launch of the State of the Climate in Africa report and subsequent releases. The Chair always stressed the need for strengthening the NMHSs, the need for acquisition and processing of quality data for the development of the state of the climate report and other applications including early warnings.

3.3 AMCOMET Bureau meeting, 9 September 2022

The AMCOMET Bureau was invited to the Southern Ministerial Conference on 'Early Warning Early Action' which took place on 5-8 September 2022, Maputo, Mozambique. To optimize resources, a Bureau meeting was organized on 9 September 2022. The Bureau appreciated the adoption of the Integrated African Strategy on Meteorology by the Heads of African States (Assembly/AU/Dec.819(XXXV) and requested the development of an implementation plan, monitoring and evaluation framework as well as a resource mobilization plan. Among the other

decisions, the bureau requested the Secretariat in collaboration with the African Union Commission to organize an event at COP27 to raise the visibility of NMHSs and boost the support from Partners to implement the strategy.

3.4 EUMETSAT User Forum

EUMETSAT organized a high-level event to give an update on MTG for Africa and the African Meteorological Satellite Applications Facility (AMSAF) on 12 September 2023.

The AMCOMET secretariat, as co-secretariat of the Joint Working Group on the Abidjan Declaration, presented the concept note they developed to ensure a smooth transition to MTG and strengthen African capacities to access meteorological and climate satellite data, and to deliver, through innovative products and services, adequate information to decision-makers in various socioeconomic sectors.

His Excellency Mr Jean Ernest Massèna Ngallé Bibéhè, Minister of Transport of Cameroon, the AMCOMET Chair delivered a statement appreciating the work of the joint working group led by the African Union Commission, with the support of EUMETSAT and called on partners to urgently support the project which is essential for the production of weather and climate services in most African countries. The AMCOMET Chair signed the Dar es Salam high-level statement on MTG-AMSAF.

4. Implementation plan and resource mobilization plan

The AMCOMET secretariat has recruited consultants to develop the implementation plan, monitoring and evaluation framework and resource mobilization plan as per the AMCOMET bureau decisions. The AMCOMET secretariat has guided the consultants and overseen the development of these documents with the support of WMO and AUC. A webinar with AMCOMET Experts, RCCs, AUC and partners was organized on 30 October 2023 to enable the consultant to present the documents and get feedback for their finalization. The revised documents have now been submitted for further review, two months before the validation and approval during the upcoming AMCOMET-6 session to be held in May 2024.

5. AMCOMET in AU Policy Organs

The African Union Commission submitted, as requested by the AMCOMET-5 Declaration, the AMCOMET report, AMCOMET-5 Declaration and the integrated African Strategy on Meteorology (the Strategy) to the Specialized Technical Committee on Agriculture, Rural Development, Water and Environment (STC4 ARDWE), in December 2021. The STC adopted all submitted documents and requested the Executive Council of AU to endorse the Integrated African Strategy on Meteorology. The STC also requested AUC to develop a monitoring and evaluation framework. The Members who attended the STC (Cameroon, Cote d'Ivoire, Egypt, Eswatini, Mozambique, Niger) contributed significantly to this achievement. They defended well the need to approve the Strategy together with the Climate Change Strategy and Disaster Risk Reduction Strategy.

The AU Executive Council adopted the Strategy on its decision EX.XL/Dec1143 (XL) of 2022. The Strategy was subsequently adopted by the Heads of States (Assembly/AU/Dec.819(XXXV) during the 35th Ordinary Session, 5-6 February 2022).

STC-5 took place on 14-16 November 2023. It was again actively attended by few Members (Cameroon, Niger, Tanzania, Uganda). STC-5 adopted the AMCOMET report and requested AUC to establish and operationalize a monitoring mechanism of the national capacity to produce weather, climate services and early warnings in Africa with the support from WMO and the AMCOMET secretariat, and present a biennial review report to the following meeting. STC-5 also requested Members, as well as partners, to increase their investments in

hydrometeorological infrastructure, data collection and service provision to improve "advanced" functional capacities of the NMHS in support of decision-making in the various socioeconomic development sectors such as agriculture, health, infrastructure, energy, etc.

6. Other Activities

Some activities of the AMCOMET secretariat to note include:

- Provision of technical advice to AUC for the ClimSa project and for PUMA upgrade
- Provide support to Members in facilitating the maintenance of PUMA Stations (e.g. Cape Verde, Senegal, Sierra Leone, etc.)
- Adding new data in EUMETCAST Africa (Rainfall estimates, Rapidly Developing Thunderstorms)
- Participation and contribution to the webinar on MTG, March 2021
- Participation and contribution to the webinar on Climate, June 2021
- Participation and contribution to the webinar on Blue Economy, December 2021
- Participation and contribution to the webinar on Nowcasting, March 2022
- Participation and contribution to the webinar on Hydrology
- Maintenance of the AMCOMET website: the AMCOMET secretariat manages the content of the website, keeps it up to date with relevant information relating to AMCOMET and its members. With the new WMO communication strategy, the website will be migrated into the WMO website as a minisite of the regional office website.

7. Status of Implementation of AMCOMET Declarations and Decisions

The level of implementation of AMCOMET Declarations and decisions is relatively low. However, the secretariat has made efforts to deliver on key strategic decisions. Good progress has been made for some decisions relative to Members. There has been an increase in countries who have gained semi-autonomy. Replacement of mercury-based equipment, implementing Quality Management Systems (QMS) and ISO-certifications are some of the other achievements. The exact figures need to be collected through survey and voluntary reporting of Members. This will be easier in the future with the new monitoring and evaluation framework and AUC STC-5 decisions requesting AUC to submit a biennial report.

Table 2 shows the detailed status of AMCOMET Declarations and Decisions.
