

AMCOMET BUREAU MEETING

9th September 2022

Maputo, Mozambique

AMCOMET Bureau took place on 9th September 2022, Maputo, Mozambique, back to back with the Southern Africa High level Conference on 'Early warning Early Action' and the release of State of Climate in Africa' report 2021 where AMCOMET Chair, H.E. M Jean Ernest Massena NGALLE BIBEHE delivered a statement.

The Bureau deliberated on the agenda items in the annex and approved the following recommendations and decisions:

- On the issue of the AU adopting ACMAD as its technical arm on meteorology, experts recommend formation of a taskforce to gather adequate information in order for ministers to be able to make an informed decision. The Taskforce will among other things do the following:
 - (i) Work with the ACMAD Board to clarify the relationship between ACMAD and UNECA
 - (ii) Identify the unique role of ACMAD that is not a duplication of what other Regional Climate Centres (RCCs) already do.
 - (iii) Prepare a convincing justification for the AU Policy organs to adopt ACMAD
 - (iv) Develop a sustainability plan that also includes the financial, legal, structural/institutional implications of the AU adopting ACMAD as its technical arm.
 - (v) Propose a strategy for successfully presenting the request to AU Policy organs.
- The AMCOMET Chair should lead members and the African Meteorology Community in showcasing the contribution of meteorology to development and climate action in Africa at COP-27.

- 3. Request AUC, AfDB and the organisers of the Africa Pavilion to secure space for an AUC-AMCOMET side event to present the Strategy and a panel discussion on resource mobilization
- Request Members to attend COP-27 at many as possible as to increase the visibility and access to fund
- 5. Note with appreciation the adoption of the revised Integrated African Strategy on Meteorology by the AU Heads of States and
 - Request AMCOMET Secretariat to recruit a consultant for the revision of the implementation plan
 - Request Partners to support the implementation plan of the strategy, starting with the urgent issue on funding the MTG-AMSAF for the preparations of Africa for a smooth transition to MTG
- 6. Sensitise Members to sign the constitution and pay their contribution
- 7. Take up the issues of signing/ratifying the constitution to AUC for legal advice in terms of the Vienna Convention
- 8. Expedite the establishment of AMCOMET CDSF Fund: The Chair to engage with AfDB Executive Officials
- 9. WMO to explore the possibility of giving priority access to NMHSs in the continent to access SOFF
- 10. Take note of the lessons learnt from this Southern Africa conference on EWEA, and organise similar event in all subregions of Africa. Welcome Niger offer to host the western Africa Conference
